What is a Paul Harris Fellow?

When \$US1000 is contributed to The Rotary Foundation, a request can be made for an individual to be recognized as a Paul Harris Fellow; that person can be a Rotarian or a member of the community who is not a Rotarian.



When a person is recognized as a Paul Harris Fellow, they are presented with a Certificate signed by the Rotary International President and the Chairman of the Trustees of The Rotary Foundation, and a lapel pin and medallion. The contribution to The Rotary Foundation can be made in one sum or by cumulative giving over a number of years. Individuals can make a personal contribution or the contribution can be from a club, a company or business.

Some of the misconceptions or misunderstanding surrounding a Paul Harris Fellow are:

- There is no such thing as a Paul Harris Fellowship, and it is not an award; it is simply recognition. When a Club contributes \$US1000 to The Rotary Foundation, the Club sets its own criteria for naming a Paul Harris Fellow. Usually this is done to recognize an outstanding commitment to the Club or the community.
- A personal contribution of \$US1000 and the subsequent recognition of a Paul Harris Fellow should be encouraged not criticized; it is a donation to The Rotary Foundation, Rotary's own charity and, therefore, every Rotarian's own charity.
- Recognition as a Paul Harris Fellow was never intended to be an award and certainly is not Rotary International's highest award, although it is an honor to be named a Paul Harris Fellow.
- Honorary Membership is the highest distinction that a Club may bestow on a Rotarian and should only be bestowed in exceptional cases for meritorious service in the furtherance of Rotary ideals and for support of the Rotary cause.
- Club Presidents may also award one Avenues of Service Citation each year to a Club Rotarian.
- The highest award an individual Rotarian can receive is the Service Above Self Award; only some maximums of 150 are awarded each year by the Board of Rotary International.
- Being named a Paul Harris Fellow is not unique. There are more than one million Paul Harris Fellows worldwide.
- Every Rotarian should strive to be a Paul Harris Fellow because for each PHF named, we know that US\$1000 has been given to The Rotary Foundation. Similarly, for each sapphire or ruby added to a Rotarian's PHF pin, an additional US\$1000 has been given to The Rotary Foundation. We should celebrate each of these milestones (and gem stones) for what they represent. That is, a gift to The Rotary Foundation and an opportunity to do even more good in the world through the Foundation.

What about when my Club names me a Paul Harris Fellow? Or, adds a sapphire or ruby to my PHF pin?

Be very proud and honored. In your name the Club has donated the sum of US\$1000 (or more) to The Rotary Foundation.

The Club is honoring you in a very special way and you should be proud of that, however you are still encouraged to personally make contributions to the Foundation and it should not discourage others to make further contributions on your behalf to continue to support the programs of the Rotary Foundation.

Remember, a Paul Harris Fellow recognizes an individual who contributes US\$1000 to The Rotary Foundation or has that amount contributed in his or her name.

After retiring from Mobil Oil several years ago Ed became involved with Learning Ally, originally founded in 1948 as "Recording for the Blind." Its mission was to serve veterans who were blinded in WWII and wanted to attend college on the newly passed GI Bill. Over the years it has grown from a small volunteer effort to a national organization that is committed to serving students who are blind or visually impaired. They provide high quality audio textbooks and strive to "connect you with a community of your peers."

Learning Ally

TOGETHER IT'S POSSIBLE

Learning Ally is a nonprofit volunteer organization operating nationwide in the United States. It produces and maintains a library of educational accessible audio books for people who cannot effectively read standard print because of visual impairment, dyslexia, or other disabilities.

Learning Ally provides a wide range of services for individuals with print disabilities as well as the people who support them. This includes services for parents such as phone consultations, webinars, support networks and information on specialists and tutors; and services for teachers such as classroom management tools (Teacher Ally), professional development workshops and lesson plans.

Learning Ally also offers a robust digital audio book library that includes the world's largest collection of audio textbooks. The library, which in 2015 contained more than 80,000 titles, includes a broad variety of specialty and academic subjects, from kindergarten through postgraduate and professional.

Borrowers must provide a certification of their disability, and may borrow titles through an individual membership, through their association with a member institution such as a school, or both. In recent years, approved borrowers had paid no charges or fees for this service thanks to funding provided by the U.S. Department of Education. Since the federal appropriation was eliminated in 2011, Learning Ally began requiring an annual membership fee for individuals, currently \$119, with hardship waivers available for those who qualify. Learning Ally Audio software for mainstream mobile devices and Learning Ally's Link software for Mac and PC are available to members free of charge. Institutional memberships are also provided at various fee levels to public and private schools, colleges and universities.

Textbook and literature titles are digitally recorded by human narrators and produced in downloadable audio files in a specialized format, which allows Learning Ally to respect copyright and allows users to navigate their audio books by chapter or page number, set bookmarks, speed up playback, etc. Downloadable audio textbooks can be played using mainstream devices like the iPad, iPhone, and iPod Touch, as well as Android smart phones and tablets, Mac-OS or Microsoft Windows-compatible computers running Learning Ally's Link software. The audio books can also be played back on assistive technology devices like the Plectalk, Humanware Stream, and Intel Reader, to name a few.
