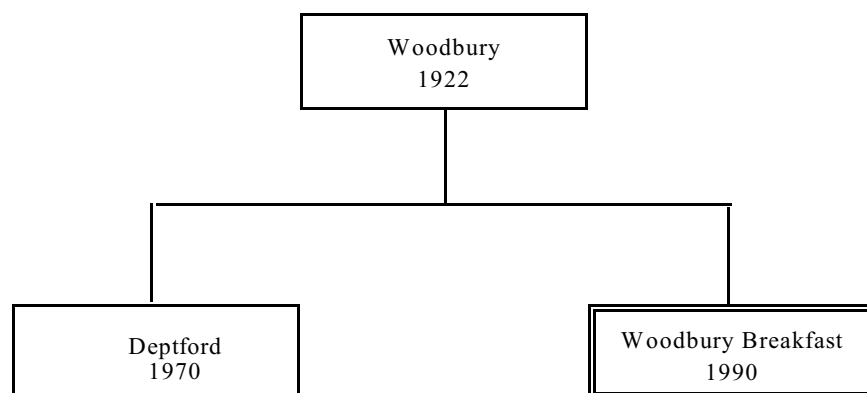

### Woodbury Rotary Sponsors a Breakfast Club

One of District Governor Herbert A. Budd Jr.'s hopes for his year was to see the addition of a 65th club during his year in office.

As a result, long-time Woodbury Rotarian Budd supported the formation of a second club in Woodbury - the Woodbury Rotary Breakfast Club.

As of press time for this publication, the breakfast club had met six times and was designated as "provisional," which meant it was meeting on a regular basis but was not yet official.

It was the hope of Budd and other district officials, including PDG Lou Joyce of Blackwood Rotary, that the Woodbury club would organize in time to have its charter night on the same night as the District Changeover Dinner - June 30 at Venice Caterers in Berlin. The club was officially notified by R.I. that its charter date was June 12, 1990.

After the fifth meeting at the Homesteader Restaurant in Woodbury, the provisional club had 29 paid members, which is two

more than the Rotary International mandated minimum for a new club. Four or five members of the Woodbury lunch club decided to resign and then become charter members of the new club. They all agreed that a breakfast meeting was more conducive to their schedules.

Sal Bellia, a member of the Woodbury luncheon club, was serving as Gov. Budd's special representative in the formation of the new club. Joyce and fellow PDGs Bill Lamon and Herb

North were among those who attended the early meetings and showed their support for the 65th district

club.
